This is mandatory; otherwise the Bid will be treated as "Non-Responsive" and will be rejected.
2. The Bids will be opened in the presence of bidder's representatives, who choose to attend at the venue, date and time mentioned in the above table. An authority letter of bidder's representative will be required to be produced.

3. The India Literacy Board, Literacy House, Kanpur Road Manas Nagar, Lucknow reserves the right to cancel any or all the bids without assigning any reason thereof. The decision of India Literacy Board, Literacy House will be final and binding.
4. In the event of date specified for Bids opening being declared a holiday for India Literacy Board, Literacy House, then the due date for opening of Bids shall be the following working day at the appointed time and place.
5. The bidder is expected to examine all instructions, forms, terms and specifications in the Bid document. Failure to furnish all information required as per the Bid document or submission of "non-responsive Bid" shall be the bidder's risk and may result in rejection of the Bid in question.
6. The Bid prepared by the bidder, as well as all correspondence and documents relating to the Bid exchanged by the bidder and the Client (ILB) shall be written either in English or Hindi language.

## **Bid Form**

The bidder shall purchase the Bid Form from the office of India Literacy Board and will complete the Bid Form as prescribed therein.

## **Bid Price**

The bidder shall quote the price separately in a separate sheet duly sealed in a separate envelope with caption "Financial Bid" and name of work and Firm. The Prices shall be quoted in Indian Rupees only.

## **Bid Submission**

**Bids will be submitted in a big sealed envelope which will contain two separate sealed envelopes inside; one envelope will contain Technical Bid with EMD and the other envelope will contain Financial Bid.**

## **Period of Validity of Bid**

- 1- Bid shall remain valid up to 90 days after the date of Bid opening prescribed by the Client (ILB). Bid valid for a shorter period shall be rejected by the (ILB) as non-responsive.
- 2- In exceptional circumstances, the Client (ILB) may solicit the bidder's consent to an extension of the period of Bid validity. The request and the response thereto shall be made in writing. A bidder may refuse the request without forfeiting its Bid security. A bidder granting the request will not be required nor permitted to modify its Bid.

## **Sction II**

### **TERMS & CONDITIONS OF TENDER**

1. The Bidder will have to supply the benches & tables (combined)/ products.
2. All products will have a Warranty Period of 03 years.
3. It is mandatory to deposit EMD with the Technical Bid.
4. It is mandatory to attach the certificate of experience.
5. The bidder must have implemented minimum three same work in the private

schools/ educational establishments/ Central or State Governments in the last 3 years including the current financial year.

6. The bidder firm will have to attach Certificate of Goods & Service Tax (GST) registration along with tender documents.
7. Tender Document will not be accepted on photocopies/ Xerox.
8. If the bidder is giving a bribe or any wrong information with the tender, his security deposit will be seized and the tender will be rejected.
9. After complete satisfaction of the departmental tender committee, appropriate decision will be taken keeping in view the departmental interest.
