1. Bidders are advised to study the tender Document carefully before submission of Bid. Submission of tender shall be deemed to have been done after careful study and examination of the procedures, terms and conditions of the tender Document with full understanding of its implications.
2. Tender documents will be available in the Office of the Director, India Literacy Board, Literacy House, Kanpur Road, Lucknow at the price of Rs.2,000/- (Two Thousand only) during the timelines as mentioned in the following Table :-

1. The bidders will have to deposit Rs. 2,00,000.00 (Rs. Two Lakh Only) as Earnest Money Deposit in favour of “Director, India Literacy Board, Lucknow” in the form of FDR / Bank Draft / Irrevocable Bank Guarantee along with the Technical Bid (which can be adjusted later in the amount of Performance Guarantee, in case the Work is awarded). This is mandatory; otherwise the Bid will be treated as “Non-Responsive” and will be rejected.
2. The Bids will be opened in the presence of bidder’s representatives, who choose to attend at the venue at date and time mentioned in the above table. An authority letter of bidder’s representative will be required to be produced.
3. The India Literacy Board, Literacy House, Kanpur Road Manas Nagar, Lucknow reserves the right to cancel any or all the bids without assigning any reason thereof. The decision of India Literacy Board, Literacy House will be final and binding.
4. In the event of date specified for Bids opening being declared a holiday for India Literacy Board, Literacy House, then the due date for opening of Bids shall be the following working day at the appointed time and place.

5. The bidder is expected to examine all instructions, forms, terms and specifications in the Bid document. Failure to furnish all information required as per the Bid document or submission of “non-responsive Bid” shall be the bidder’s risk and may result in rejection of the Bid in question.
6. The Bid prepared by the bidder, as well as all correspondence and documents relating to the Bid exchanged by the bidder and the Client (ILB) shall be written either in English or in Hindi language.
7. **Technical Bid** - Technical Bid will comprise of:
 - Technical Specification of the Products as per design.
 - Copy of PAN card.
 - Copy of GST Registration certificate.
 - EMD of Rs. 2,00,000.00 (Rs. Two Lakh Only) in favour of “Director, India Literacy Board, Lucknow” in the form of FDR / Bank Draft / Irrevocable Bank Guarantee.
 - The bidder should furnish experience certificates of having at least 05 years of experience including the current financial year 2024-25 in the field of similar works.
 - Bidder should furnish an Authority Letter from the OEM / Manufacturer in case he / she is bidding on behalf of the OEM / Manufacturer as an Authorised Channel Partner.

Qualification Criteria include copies of required documents as per Technical Bid justifying that the bidder is qualified to perform the contract if his/her bid is accepted and that the bidder meets the criteria outlined in the Section II Terms and Conditions and Technical Specification and fulfill all the conditions of the Contract justifying that the bidder is complying with all the conditions of the Contract and Technical Specifications of the Bid Document as no deviation will be acceptable to the Client (ILB).

Bid Form - The bidder shall purchase the Bid Form from the office of Director, India Literacy Board, Literacy House, Kanpur Road, Lucknow and will complete the Bid Form as prescribed therein. Bids shall not be accepted on Photocopies of the Original Bid Form.

Bid Price -

The bidder shall quote the Price in a separate sheet in accordance with the BoQ. The Prices shall be quoted in Indian Rupees only excluding GST / applicable taxes. GST shall be paid separately by the India Literacy Board as per the applicable GST rules.

Bid Submission -

Bids will be submitted in a big sealed envelope which will contain two separate sealed envelopes inside; one envelope will contain Technical Bid and the other envelope will contain Financial Bid. Non adherence to this condition by any bidder will be deemed to be disqualified.

Period of Validity of Bid

1. Bid shall remain valid up to 90 days after the date of Bid opening prescribed by the Client (ILB). Bid valid for a shorter period shall be rejected by the ILB as non-responsive bid.
2. In exceptional circumstances, the Client (ILB) may solicit the bidder’s consent to an extension of the period of Bid validity. The request and the response thereto shall be made in writing. A bidder may refuse the request without forfeiting its Bid security. A bidder granting the request will not be required nor permitted to modify its Bid.

Section II

TERMS & CONDITIONS OF TENDER

1. The Bidder will have to do Supply & Fixing of Pre-cast compound Boundary Wall along with complete job of civil & masonry works at Neewan Agricultural Farm, Lucknow.
2. Bids will be submitted in a big sealed envelope which will contain two separate sealed envelopes inside; one envelope will contain Technical Bid and the other envelope will contain Financial Bid. Non adherence to this condition by any bidder will be deemed to be disqualified.
3. It is mandatory to deposit EMD of Rs. 2,00,000.00 (Rs. Two Lakh Only) as Earnest Money Deposit in favour of “Director, India Literacy Board, Lucknow” in the form of FDR / Bank Draft / Irrevocable Bank Guarantee along with the Technical Bid.
4. It is mandatory to deposit the performance guarantee @ 5% of the total value of the awarded work within 15 days from the date of award of work. The amount of EMD may be adjusted later in the amount of performance guarantee, in case the work is awarded.
5. The OEM / Manufacturer or their Authorized Channel Partner (on behalf of OEM / Manufacturer) will be eligible to participate in the bid. Bidder should furnish an Authority Letter from the OEM / Manufacturer in case he / she is bidding on behalf of the OEM / Manufacturer as an Authorised Channel Partner
6. The bidder should furnish experience certificates of having at least 05 years of experience including the current financial year 2024-25 in the field of similar works.
7. The bidder firm will have to attach Certificate of Goods & Service Tax (GST) registration along with tender documents.
8. The bidder will have to attach the PAN CARD.
9. Tender Document will not be accepted on photocopies / Xerox.
10. If the bidder is found giving a bribe or any wrong information with the tender, his security deposit will be seized and the tender will be rejected.
11. After complete satisfaction of the India Literacy Board & keeping in view the interest of the institution, the decision will be taken accordingly. India Literacy Board shall have the full rights to reject any bid submitted by the bidder or cancel the tender, without any reason, in the administrative interest, or to change the conditions or terminate any condition. Any tenderer/ bidder will not have any right to debate on doing so.
12. The defect liability period shall be 06 months from the date of completion of the project. The bidder will have to make good any defects so occurred during the said period on his own expenditure and costs.
13. Any dispute between the Bidder Firms and Department, it will be subjected to the Lucknow jurisdiction for its disposal.
14. The Bidder is agreed to adhere to the Terms & Conditions as mentioned above.
