2. The Bids will be opened in the presence of bidder's representatives, who choose to attend at the venue, date and time mentioned in the above table. An authority letter of bidder's representative will be required to be produced.
3. The India Literacy Board, Literacy House, Kanpur Road, Lucknow reserves the right to cancel any or all the bids without assigning any reason thereof. The decision of India Literacy Board, Literacy House will be final and binding.
4. In the event of date specified for Bids opening being declared a holiday for India Literacy Board, Literacy House then the due date for opening of Bids shall be the following working day at the appointed time and place.

 - The bidder should have at least 03 years of experience including the current financial year 2025-26 in the Cabling/underground cabling works.

Qualification Details – includes copies of required documents as per Bid document justifying that the bidder is qualified to perform the contract if his/her bid is accepted and that the bidder meets the criteria outlined in the Qualification Requirement and Specification and fulfill all the conditions of the Contract justifying that the bidder is complying with all the conditions of the Contract and Specifications of the Bid Document as no deviation will be acceptable to the Client (ILB).

Bid Price -

1. The bidder shall quote the Price as mentioned in the bid document. The Prices shall be quoted in Indian Rupees only.
2. The documentary evidence of bidder's qualification to perform the Contract shall be as per Qualification Requirements specified in the tender document.

Bid Submission -

Bids will be submitted in a sealed envelope which will be addressed to Director, India Literacy Board, Kanpur Road, Lucknow clearly mentioning the name of work and name and address of the bidder.

Period of Validity of Bid

1. Bid shall remain valid up to 90 days after the date of Bid opening prescribed by the Client (ILB). Bid valid for a shorter period shall be rejected by the (ILB) as non-responsive.
2. In exceptional circumstances, the Client (ILB) may solicit the bidder's consent to an extension of the period of Bid validity. The request and the response thereto shall be made in writing. A bidder may refuse the request without forfeiting its Bid security. A bidder granting the request will not be required nor permitted to modify its Bid.

Sction II

TERMS & CONDITIONS OF TENDER

1. The Bidder will have to Supply, Lay, test and Energize the Electric Cabling.
2. It is mandatory to deposit EMD with the Bid.
3. It is mandatory to attach the certificate of manufacturer Authorization of Main Components.
4. The bidder must have implemented minimum three similar works in the autonomous establishments/ Central or State Governments in the last 3 years including the current financial year.
5. The bidder firm will have to attach PAN/TAN and Certificate of Goods & Service Tax (GST) registration along with tender documents.
6. Tender Document will not be accepted on photocopies/ Xerox.
7. The bidder will have to provide OEM Certificate.
8. The bidder will have the responsibility of maintenance and supervision for at least one year from the date of commissioning without any extra cost.
9. If the bidder is found giving a bribe or any wrong information with the tender, his security deposit will be seized and the tender will be rejected.
10. After complete satisfaction of the India Literacy Board & keeping in view the interest of the institution, the decision will be taken.
